

Official Rules

1. **Eligibility:** The game of Craction is open to legal residents of the 50 United States and the District of Columbia (EXCLUDING PUERTO RICO, OTHER UNITED STATES TERRITORIES, AND FOREIGN TERRITORIES), who are eighteen (18) years or older. This contest is open to all registered members of Craction.
2. **Registration:** By registering to become a member of Craction, you agree to release Craction, LLC of any and all liability associated with this contest. All participants shall indemnify and hold Craction harmless from any and all damages.
3. **Rules:** This contest is conducted under the general rules of Craction which are described in the 'How to Play' section of the Craction website. Each registered member must submit 5 picks per week in each sport that member chooses to participate in. Any member that does not submit 5 picks in any given week will be administered a 5 point deduction for each pick that was not made in the sport the member is participating in. By registering and joining Craction, you agree to abide by these rules and regulations.
4. **Sponsor(s):** Participating businesses that provide weekly and/or season-ending prizes to members that join a Sponsor's Public league. Each participating Sponsor determines the prize(s) that will be offered to winners on a weekly and/or season-ending basis.
5. **Qualifications:** Craction, LLC and its league Sponsors reserve the right to verify the qualifications of any winner and otherwise restrict the transfer or assignment of the winning prize.
6. **Prizes:** Craction, LLC and its Sponsors have the right to modify any prize or portion of a prize based on availability or any other unforeseen reason at any time. Prizes offered by Craction, LLC and its Sponsors cannot be redeemed by an employee or contracted employee of Craction, LLC.

7. **Winners:** All winners are responsible for contacting the League Sponsor to claim their prize. Neither Craction, LLC nor its Sponsors are responsible for unclaimed prizes or prizes that cannot be released due to ineligibility or lack of sufficient proof/documentation the person is the actual winner as displayed on www.craction.com.

8. **Craction Grand Prize Leagues:** Craction, LLC will contact the winner of a Craction Grand Prize league via email on the day following the last game of the contests scheduled season to alert them of their prize. The winner must contact Craction, LLC by e-mail within 48 hours to redeem their prize. In the event of a tie, all first place winners names will be placed into a drawing conducted under the supervision of an accredited law firm to be held on the following business day after a contest has ended.

9. **Travel:** For prizes which involve travel, Craction, LLC will notify the winner and his/her guest of the date and time of their flight to and from their destination. The winner and their guest must be able to travel during the times selected by Craction, LLC. In the event a hotel and/or accommodations become unavailable, Craction, LLC reserves the right to modify the prize as they see fit. Craction, LLC will determine which major airport is closest to the winner's place of residence and will provide two commercial flights from that location. Winner and his/her guest may be subject to gratuities, taxes and any additional airline fees. They must also abide by all airline travel restrictions and present all necessary documentation needed to travel. The winner and his/her guest may be asked to sign a release prior to accepting their prize and begin travel to their intended destination.

10. **Gambling Prohibition:** The game of Craction is strictly for entertainment purposes and may not be used in connection with any form of gambling. This contest is not considered a contest that is subject to odds or any type of random selection of winners.

human intervention, e.g., hacking; (5) technical or human error which may occur in connection with any aspect of the game of Craction; (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the game of Craction, access to, copying or downloading materials from www.craction.com or any other website, or receipt or use of any prize.
